2. Operate Notes.

(1) Check equipment safety before operating

A: Ensure seat belts, handles are solid and reliable, without damage.

B: Ensure the switch of the cabin door is flexible, closed prison and insurance devices is working.

C: Key location of the pin, the weld has no obvious deformation, cracking or other abnormalities.

D: Fasteners that are fixed to the floor are not loose and fall off.

E: The wire is not broken and naked

F: According to the actual conditions of no-load operation more than 2 times to confirm that everything is working properly before formal operation

(2) Guide the experience of experience equipment.

A: Stop the experimenter or rush to board on the cabin. Do not rush to unlock the seat belt, wait for the device to stop and then release the seat belt.

B: It is strictly forbidden for onlookers and experimenter to cross the safety fence or stay within the safety fence to prevent being hit by the running equipment.

C: It is strictly forbidden to take the overstaffer, the boarding experience must meet the requirements of the experience before experience.

D: As the experience will rotate with the machine from time to time 360 degrees, so experimenter is strictly prohibited to carry any fragile goods and external objects (such as cell phones, keys, bags, etc.) into cabin.

3、Business Notes

(1) In order to ensure that the experience as soon as possible to familiar with the operation process and safe operation, should be equipped with a professional instructor. The instructors need to go through our company's professional technical training and common knowledge processing training.

(2) Before experimenter the experience, the instructor should preach the

equipment customer notes.

(3) Pay attention to observe the physical state of the experiencers, if customer physical discomfort or do not meet the requirements of the experience, the instructor need to persuade patiently to convince customers to give up experience.

(4) When the customer enters the cockpit, the instructor should explain the safety knowledge and safety precautions to customer, and check whether the safety device meets the requirements (such as whether the seat belt is locked, whether the warning light is flashing, whether the cover is locked, etc.) Ensure there are no mixed staff and security risk and then issued a formal operation command procedures.

(5) During the equipment operation process, the instructor shall not leave his post without authorization. He should concentrate his attention closely on whether the experiencer comply with the safety requirements or not and stop it if found.

(6) If it is found that the experience loudly exclaims to produce fear or serious incompetence during the equipment operation process, the instructor should immediately press the emergency stop button and bring the customer out of the cabin to comfort after the equipment stop stably.

(7) During the equipment operation process, must always observe the situation of passengers and equipment, in an emergency situation, the instructor should be shut down in time and take the appropriate measures.

(8) At the end of the operation, the main power supply should be switched off and check the safety of equipment.
